Lessons Learned on Accredited Entities Coordination Meeting July 2021

Background

The Fiscal Policy Agency, Ministry of Finance (FPA-MoF), as the National Designated Authority of the GCF, has conducted the 2nd Call for Project Concept Notes (PCN), an initiative designed not only to develop Indonesia's project pipeline but also to build the capacity of national stakeholders in designing climate projects/programs. The Call for PCN enables the NDA to identify promising project ideas that would need development assistance to be mature. It also enhances country ownership as the projects will be demand-based. The shortlisted applicants have received technical assistance from the NDA through the GCF PCN Writing Workshop and will move forward to the matchmaking clinic session.

The NDA GCF Indonesia held a coordination meeting with all (D)AEs operating in Indonesia to introduce the shortlisted concept notes and provide information on the matchmaking clinic session. The coordination meeting was also organized to be a sharing platform for (D)AEs to present their GCF project pipeline updates.

Implementation

The meeting with (D)AEs was conducted virtually on July 21st, 2021, attended by 21 participants (28% of which are female) representing 11 AEs that operate in Indonesia. The NDA GCF Indonesia introduced the list of shortlisted concept notes from the second Call and shared the agenda for the matchmaking clinic. Following the success of the First Call, the matchmaking clinic objective was to match potential interest between (D)AEs and the proposed projects. (D)AEs active participation and cooperation for the matchmaking event was expected to further enhance the collaboration of (D)AEs and project proponents in Indonesia. Further in the meeting, the (D)AEs also presented their progress updates on the current and planned GCF project pipelines.

Results: Project Pipeline Updates

During the sharing session, it was recorded that there are several progresses on current pipeline as below:

KDB is currently discussing the legal agreement with GCF, and in discussion with GGGI as one of implementing partners for the program.In collaboration with the ASEAN Centre of Energy (ACE), KDB will submit the "Supporting Innovative Mechanisms for Industrial Energy Efficiency Financing in Indonesia with Lessons for Replication in the other ASEAN Member States" proposal.
PT SMI	<p>Green Hybrid Microgrids for Small Islands in Indonesia</p> <ul style="list-style-type: none">In collaboration with Électricité de France, the draft of concept note has been submitted to the GCF to receive initial feedback. Concept note is now being improved.Technical Assistance is provided by the GCF (in the form of a Project Development Consultant) to support PT SMI upon three key deliverables: (1) Advising PT SMI on the eligibility of activities proposed under this project. (2) Advising PT SMI on GCF policies, guidelines, and proposal development requirements, (3) Assisting PT SMI during the development of a consolidated Concept Note for CIC2 submission.

Kemitraan	<ul style="list-style-type: none"> • Kemitraan has just signed the accreditation master agreement (AMA) with GCF. • At the beginning of June, Kemitraan has submitted the Adaptation Financing Facility concept note draft to the GCF to receive initial feedback. • Kemitraan has four concept notes on its pipeline and is in the process of accelerating the development and alignment of the concept note to GCF.

Best Practices

- The coordination meetings between NDA and (D)AEs have served as a platform between (D)AEs to communicate, share and learn on current and future GCF pipeline in Indonesia. This approach is well appreciated by the (D)AEs to avoid potential overlapping activities between proposed concept notes/proposals. The NDA also encourages (D)AEs to collaborate and/or bundle some projects, while communicating with relevant technical Ministries to gain inputs and ensure country ownership.
- (D)AEs can now refer to the updated Indonesia Country Programme Document (CPD), which lists Indonesia GCF pipeline from different (D)AEs, including its planned submission timeline to GCF. The pipeline remains a living document, which will be updated accordingly.
